<u>Mooring Buoys</u>

An article in Pacific YachtingREF caught my eye and caused me to go huh, interesting. The title of the article was 'Can you tie up? Can you drop your own? Everything you need to know about mooring buoys in BC'REF. Yeah, I know it applies to British Columbia and I don't know what Washington law has to say about it, but the answers to the questions gave me pause. The questions posed were:

'With so many mooring buoys in our bays, many of them unoccupied, what are the rules: 1) Is there a public right to install a mooring buoy? and 2) if there is, does the owner of the buoy have the exclusive right to use his or her buoy, or must it be shared with other boaters?'^{REF}

The answer to these questions is: it depends, yes and no, use common sense, don't trespass without permission. The Canadian Federal government regulates the right to navigation on navigable waters, and that right includes a right to anchor. But the right to anchor is only for a reasonable time and for a reasonable purpose. The provincial government administers the seabed and 'owns the land under the "inland seas" (such as the Juan de Fuca Strait, the Strait of Georgia, Johnstone Strait and Queen Charlotte Strait) and bays, as well as the foreshore between low and high tide.'REF And further 'There is no such thing as "squatter's rights" in BC, so a private mooring buoy installed without provincial approval will be in trespass.'REF The provincial court further specified that the right to navigation and anchoring be without interfering with the equal rights of others, which includes recreational boaters. Another buoy guideline is that buoys be marked with the name and phone number of the buoy's owner. Hence the obligation to contact the owner before using their buoy. If they don't answer the phone, you are on your own on what you decide to do.

The article does a much more thorough job of the laws and legalese. The bottom line along with it depends, yes and no, and common sense. I would add common courtesy that we as recreational boaters are <u>known</u> to exhibit.

As you can see from the above narrative, I am still in the <u>huh</u> mode concerning mooring to an unused buoy unless it is obviously meant for public use. What we usually do is abort Plan A and go somewhere else. When in doubt don't, unless it is an emergency, then safety always comes first.

For me, December is a time for reflection on the past year. What has been accomplished, what projects were completed, what I learned and so much to be grateful for.


The other part of December is the planning for the year to come. By examining the past year, and my past and future goals, I establish my goals for the year to come.




What's included?


