




Environmental Report

The Swapping of Magnetic Poles

Many of you, as I didn't, know that the magnetic north pole is moving farther East at an unusually fast pace. From the Canadian Arctic east toward Siberia at a rate of approximately 30 miles per year. The shift has been variable and has been doing so forever. The fact is that the north poles will eventually swap from one end of the earth to the other. Scientists say this usually happens every 200,000 – 300,000 years, but this one is way overdue, it's been over 700,000 years since the last swap. The reason for the shift or movement of the magnetic is said to be caused by the action or changing course of the molten iron core at our earth center. Some of you may wonder what this means to us, well there's the obvious it screws up navigation something fierce. There are animals, birds, that depend on their internal compass to get them around (say flying south for the winter). It usually weakens the magnetic field that surrounds the earth. This field is what protects us from deadly radiation. No one knows if this movement will speed up or slow down.

Scientists don't exactly know what will happen to us (well not us) no evidence proves this is what led to the extinction of the dinosaurs. The good news is that it usually takes thousands of years to make the swap and that should give us some time to get around problems caused by the swapping of earth magnetic poles. I suppose the bad news is, it's been 700,000 years since the last swap. A Geomagnetic excursion happened about 41,000 years according to Wikipedia the Excursion (not a reversal) recorded in the Laschamp Lava flows in France, but not studied until the 1960s. An Excursion is different from a Reversal because the excursion is not a total swap of the Earth's Magnetic poles. Either action can still wreak havoc by weakening the magnetic field and allow radiation to enter the earth's atmosphere messing up communications and navigation amongst other things.

Recreational Boating Association of Washington (RBAW)

This report is published with permission of Past Commodore Day Island Yacht Club Chuck Gay. These reports will keep us updated on the current Washington legislation regarding area boaters.

Strong support for funding enhancements to the Derelict Vessel Removal Program (DVRP) and increased use of the Vessel Turn-In Incentive Program

The Governor's proposed 2019-21 Capital Budget is very positive for us in that it includes \$5 million to help the Department of Natural Resources (DNR) catch up on the costs of removing some of the biggest and most expensive vessels.

Support consensus recommendations from Southern Resident Killer Whale (SRKW) Task Force, while opposing a \$10 fee 'opt-out' fee on boaters and any 'no-go' zone that is not imposed on all vessels

There is pretty good news to report on the pending Orca Task Force "vessel" bills. We aggressively laid out our concerns with a \$10 fee on boaters that had been introduced at the very end of the Task Force process and also pushed back on a vast "no-go zone" in Orca feeding areas. As amended, **2SSB 5577/2SHB 1580** changes a 200-yard protective bubble around the Orcas to 300 yards – except with respect to vessels position behind the whales, which have to be at a 400-yard distance. The bill also includes a 7-knot 'go-slow' zone within one-half nautical mile of the whales when they are present. All in all, not a bad outcome given some of the proposals we saw during the Task Force process.

Enact 2019-21 Capital Budget with Robust Funding Allocations for Recreational Boating and Outdoor Recreation Grant Programs:

The Governor's proposed Capital Budget includes \$17.8 million for Boating Facilities Program grants to state and local agencies that operate boat launches, as well as \$2.2 million for the federal-pass-through "Boating Infrastructure Grant" (BIG) program. It also includes \$115 million for the Washington Wildlife & Recreation Program (WWRP) – which has a non-motorized water access category of grant funding.

Big Tent Outdoor Recreation Coalition/Outdoor Recreation Caucus

RBAW supports the work of the "Big Tent" Outdoor Recreation Coalition, an umbrella organization comprised of several dozen outdoor retailers, non-profits, and others that seek to ensure Washington State recognizes and maximizes the economic, societal, tourism, and health benefits of outdoor recreation.

Study of what to do with copper-bottomed paint used on vessels: A study of what to do to reduce the use of copper in paint and in water bodies was a part of **HB 2634** passed in 2018. The study being done by the Department of Ecology will be completed by September 2019 and will lead to some recommendations for the 2020 Legislature.

SECTION I - SPECIAL NOTICES

This section contains information of special concern to the Mariner.

OREGON – WASHINGTON – IDAHO – GPS equipment notice

At midnight on 06 Apr 2019, a parameter in the GPS system will "roll over" to zero, which may affect older GPS equipment, or equipment that has not received firmware or software updates recently. The GPS satellite constellation transmits the exact time to all GPS receivers. The format for this information includes a parameter that represents the week, called the GPS week number. The week number has been counting incrementally by one since 05 Jan 1980, and is an integral part of the navigation message received by all GPS receivers. When the week number reaches 1024 at 18 seconds before midnight (UTC) on 06 Apr 2019, it will reset to zero as it keeps counting. This has happened once before - In August of 1999. Older GPS receivers, or receivers that have not been provided manufacturer updates, may be impacted by the rollover. The impact might occur in April, or could affect such equipment at a later date. On these receivers the date might revert back to August 1999, or may revert to another date. Since this issue does not affect the other parts of the GPS navigation message, (it only affects the date), the receiver's ability to calculate the position and to display the exact time of day should not be impacted. If you are operating a recently manufactured GPS receiver, it has likely been designed to handle this rollover event. If you regularly update your equipment's software/firmware with manufacturer updates, it has likely been prepared to handle it. If you are unsure, check with your manufacturer. If the equipment was built to the following published specification, it will handle the rollover without problem: Global Positioning Systems Directorate Systems Engineering and Integration Interface Specification, IS-GPS-200. If your receiver shows symptoms similar to those described above, it is recommended that you contact your equipment manufacturer for further assistance. To best prepare for this rollover event, users of GPS equipment who are concerned should update their firmware, or contact their equipment manufacturer to ensure their equipment is ready for this event. For additional information about GPS and the GPS Week Number Rollover visit www.GPS.gov. Civil GPS users are encouraged to report disruptions or anomalies to the U.S. Coast Guard Navigation Center or via phone at (703) 313-5900, 24 hours a day.




