

Welcome to summer everyone. In July of 1838, a man was born by the name of Bass Reeves. Mr. Reeves was the first African American Deputy US Marshal West of the Mississippi River. He spent most of his time working in Arkansas and the Oklahoma

Territory. Some believe he was the inspiration for the radio program The Lone Ranger. Historian Art Burton made that claim and based it on the fact that Mr. Reeves made over 3000 arrests without receiving any major injuries, also many of the people he arrested were jailed in the same city (Detroit House of Correction) where The Lone Ranger radio program aired. Like everything else, there are people that dispute that theory. Bass Reeves made over 3000 arrests and shot 14 people in self-defense. Born a slave in July of 1838 (no day is on record) in Crawford County Arkansas, Bass Reeves died on 12 January 1910. When you have time, take a few minutes and look up the life of a true Lone Ranger, Bass Reeves.





#### **Docking in the Wind at Poulsbo**

Wham! That was the first indication of trouble during our second day of moorage at Poulsbo about halfway down E dock. A 34-foot Mainship slammed sideways into the bow of my 3288 Bayliner, GreyWolfes'. I didn't see it coming as we had rigged up shades to cut the late afternoon glare reflecting off the water at our slip. The really bad news is that we hadn't heard the screams and shouts farther down the dock when this boat hit two others seconds earlier as it entered the fairway.

So, what happened? Well, the older couple running the boat were coming into the Port of Poulsbo in the late afternoon with a strong north wind blowing across the fairways. He was working the fenders and dock lines and she was driving. They were communicating via headsets. Just before entering, he told her, "There is a strong wind, so you have to be quick." I understand what he meant, quick to act, decisive use of the controls, rapid use of bow and stern thrusters to correct for the wind when close to the dock. It seems she mistook quick for fast. They powered the boat into the fairway moving very rapidly while underestimating the wind's strength.

They struck four boats, all along the north side but not all contiguous to each other. There were empty slips and shorter boats between victims 2 and 3 (me) so it wasn't as bad as it could have been. Since damage involved more than \$2000 among the five involved boats, a couple of us called 911 to report a boating accident. The Pouslbo police responded in a matter of minutes and took statements. I can't recite the damage to all the other boats but mine sustained damage to the bow rail, Smart Plug power cable, and my pet ramp. Luckily, my boat sustained no gelcoat or fiberglass damage, at least as best I could see from my inspection. I was able to repair my bow rail by resetting the set screws that hold the railing at each joint. My pet ramp is still serviceable, so it was not of concern. My power cable was damaged at the head where it plugs into the boat. I asked that the other party replace the cable and he agreed. Since one of the other parties is making an insurance claim, the individual is waiting for guidance from his insurance company before settling any damages.

So, what's the lessons learned from this incident? First, clear communications among the crew is essential. I believe they attempted to do so but the intent was lost as things started going wrong. When entering a marina, S-L-O-W is the correct speed and mindset. Many of us observed boats entering and departing before and after, all day long, traveling very much faster than dead slow. Some even left wakes as they traveled past. That is too fast.

Enter the marina fairway compensating for the stronger of wind or current. If uncertain, enter taking your half out of the center then adjust once you determine to which side you will be pushed.

Slow speed is good as is correcting input. Deliberate changes of input without over reacting will prevent the panic response that leads to worse outcomes. If you make unintended contact, maneuver away and reset. Be prepared to go around and try again.

If you think you need help, ask for it. I've called the marina at Poulsbo during previous visits requesting docking assistance as I'm aware the winds can make docking difficult. With the weather being nice and lots of folks out boating, there was plenty of help to get this boat docked and they did so eventually with that help.


