In the meantime, the fire dept. shows up, gets all set up hooking up the hydrant to their truck. The only problem was the fire truck and hoses were now surrounding her jeep. Our Goal is to show you how to get more enjoyment out of your boat.

Engine Maintenance will cover basic practices on how to maintain your boat. By adhering to a regular maintenance schedule, you can avoid catastrophic failure, and costly mistakes. But if something does happen some simple steps you can take to diagnose and maybe fix the problem, or at least relay the information to a trained professional.

Instructors have taken this course and taught it many times. They are in the boat repair business and would like to share with you the problems they see from day to day and how to prevent them. They are not going to repair your boat in class! We hope to have a Marine Navigation class in the fall and an Advanced Marine Navigation in the spring, so stay tuned!

How your club participants make their slip reservations

- Marina slips are now held for your club participants to make their individual reservations.
- Please provide the following information to your participants to reserve a slip held for this club event:

Enter this Event Code for Clubs Only after selecting the Book Guest Moorage button: tpssept2022

Follow the steps to make a slip reservation and provide payment for the moorage

- **Participants will make their individual reservations directly** on our Marina's website by entering the club's event code to view slips held, but not yet reserved by another participant.
- These slips will be held for the club until 5 days before the scheduled arrival date on Friday September **30**, 2022, after which they become available to the general public. Club participants may continue to reserve slips if still available.
- When your club participants make their reservations, they will receive a confirmation email noting:

Payment: 100% of moorage cost is due at time of booking

Cancellations: Must be made by to receive a refund for the entirety of the reservation period, less \$10.00 processing fee

Additional information regarding: Door codes for Marina's main gate, restrooms and showers, and WiFi access details.

Another note for those with boat projects requiring parts and such. Pettit Marine located over at the big building at the head of the waterway is under new management. They have added a consignment area in a rather large shop area with access through the store. There was a lot of interesting items available for sale. Swantown has upgraded access to the showers and restrooms after hours. Formerly, you had to rent a plastic card or call security to gain access to the facilities after dark. Now, the office issues you a numeric code that you enter on the keypad at the doors.
